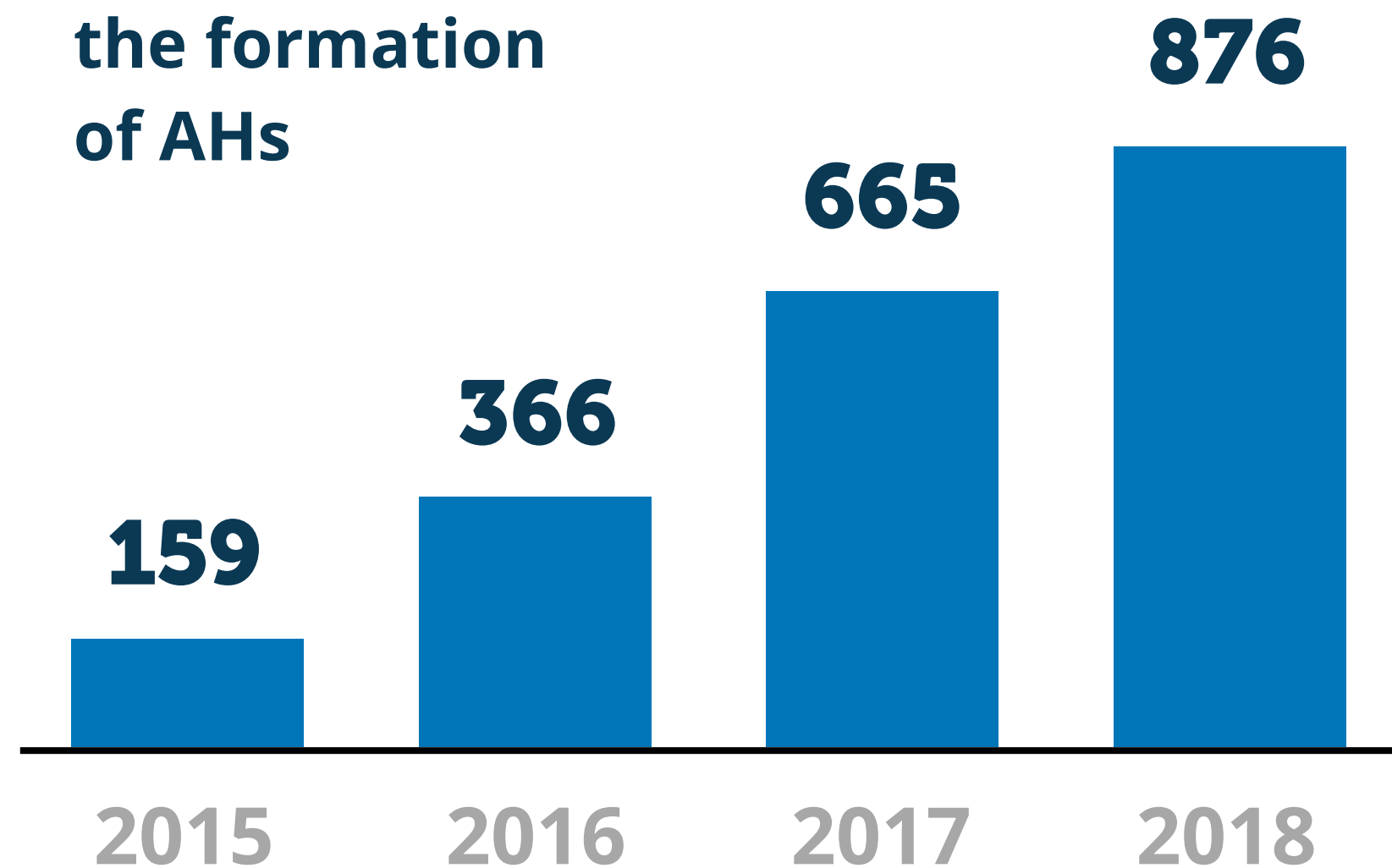

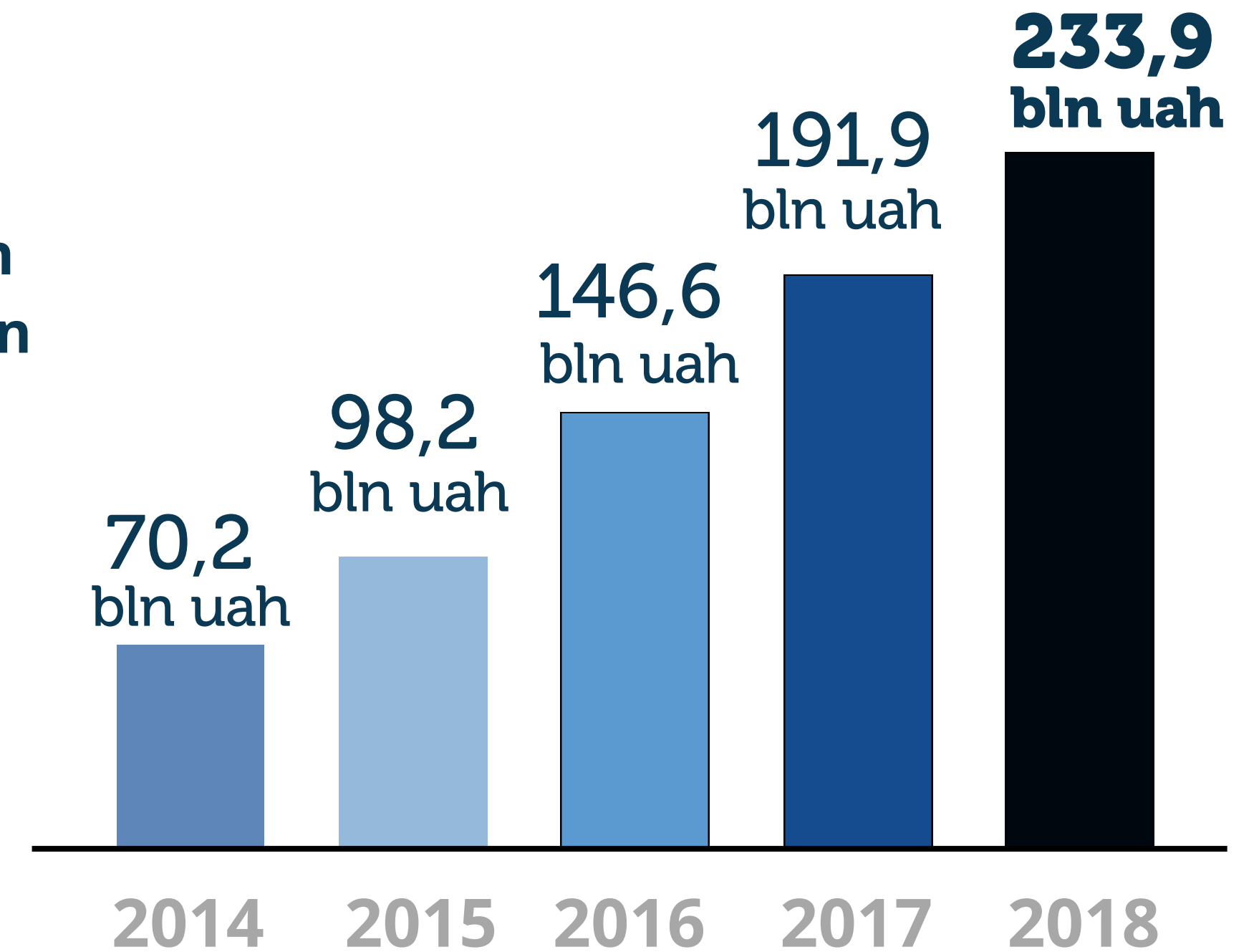

Dynamic of the growth of revenues in the general fund of local budgets



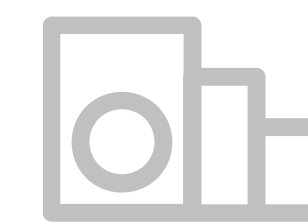

KEY OBJECTIVES

- 1** APPROVAL OF THE NEW TERRITORIAL STRUCTURE FOR THE ACTIVITY OF AUTHORITIES AT THE LEVEL OF HROMADAS AND RAYONS
- 2** TRANSFER (DECENTRALIZATION) OF THE EXECUTIVE POWERS TO LOCAL SELF-GOVERNMENT BODIES AND DISTRIBUTION OF THESE POWERS BETWEEN DIFFERENT LEVELS AND BODIES FOLLOWING THE PRINCIPLE OF SUBSIDIARITY
- 3** ESTABLISHMENT OF A SUFFICIENT RESOURCE BASE TO ENABLE LOCAL SELF-GOVERNMENT BODIES TO EXECUTE THEIR POWERS
- 4** FORMATION OF AN EFFECTIVE SYSTEM OF SERVICE AT LOCAL SELF-GOVERNMENT BODIES AND BODIES OF EXECUTIVE POWER

1 BASIC LEVEL: FINALIZING THE FORMATION OF CAPABLE HROMADAS



Amend the legislation with the provisions assigning the power to the CMU to approve the territories of hromadas, and development and adoption of legal acts on the division of oblasts into rayons

Approval of the perspective plans envisaging coverage of 100% of territory in ALL oblasts

Maximum support for the voluntary amalgamation/ accession of hromadas, especially involving cities of oblast significance

Approval of the territory of ALL oblasts — completion of the formation of administrative and territorial units of the basic level



1 RAYON LEVEL: FORMATION OF NEW CAPABLE RAYONS



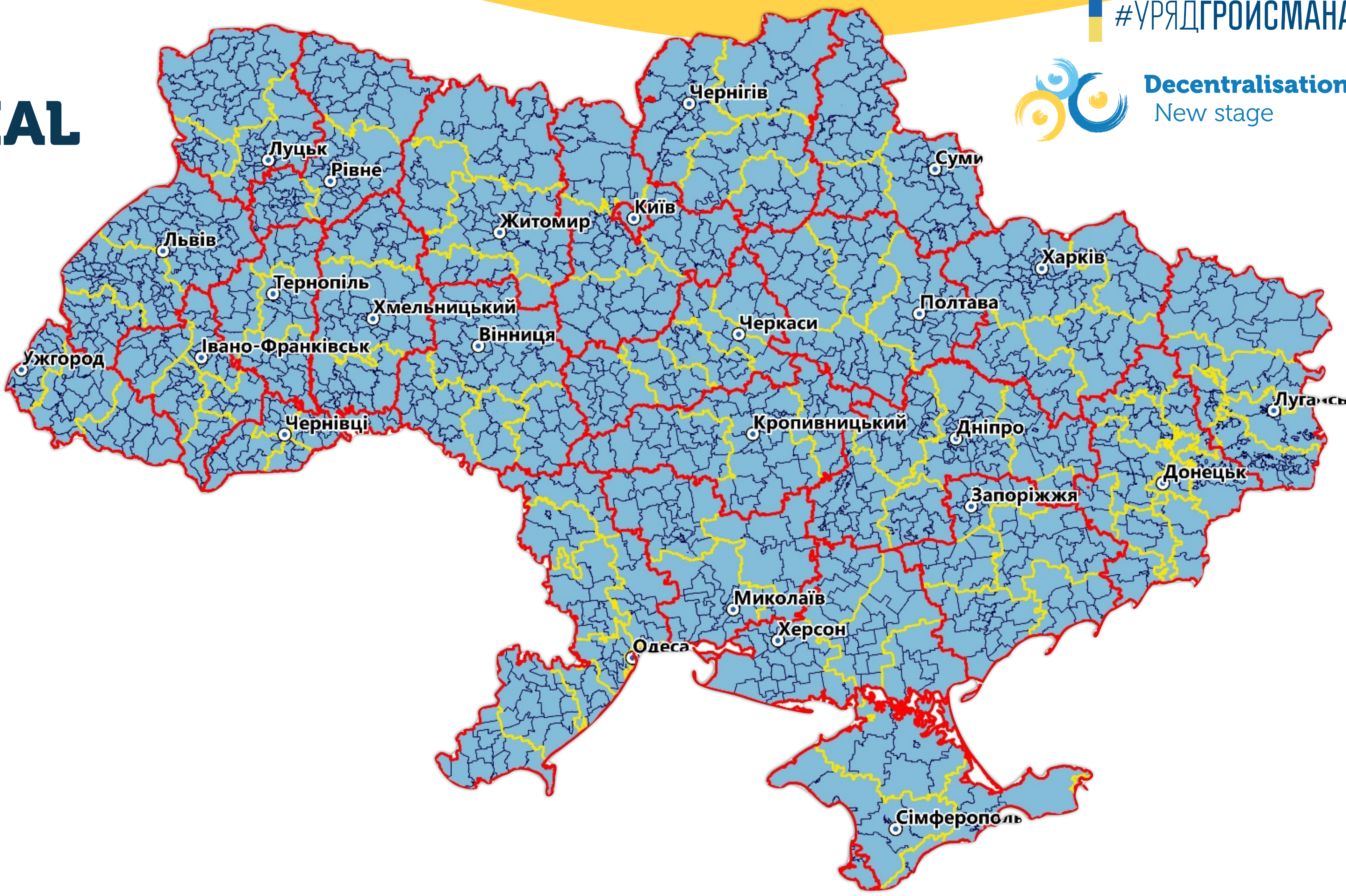
Modeling the administrative and territorial structure at the rayon level (according to the criteria on the Administrative and territorial structure)




Structuring the system of local offices of central executive power bodies within administrative districts (interim option)

Approval of the territory of ALL oblasts – completion of the formation of administrative and territorial units of the rayon level



1 NEW TERRITORIAL STRUCTURE 2020

TRANSFER (DECENTRALISATION) OF EXECUTIVE POWERS TO LOCAL SELF- GOVERNMENT BODIES AND THEIR DISTRIBUTION BETWEEN DIFFERENT LEVELS AND BODIES



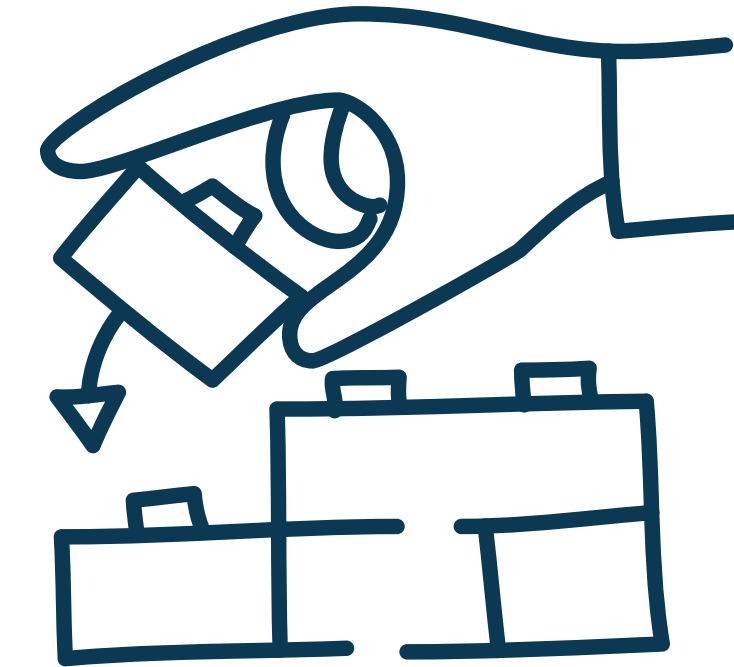
MinRegion jointly with the corresponding central executive power bodies, LSG associations, shall submit proposals on introducing amendments to the legislation

Transfer of executive powers to local self-government bodies following the principles of subsidiarity

Separation of powers between local state administrations and local self-government bodies



ENSURING RESOURCES NECESSARY TO ENABLE LOCAL SELF- GOVERNMENT BODIES TO EXECUTE THEIR POWERS



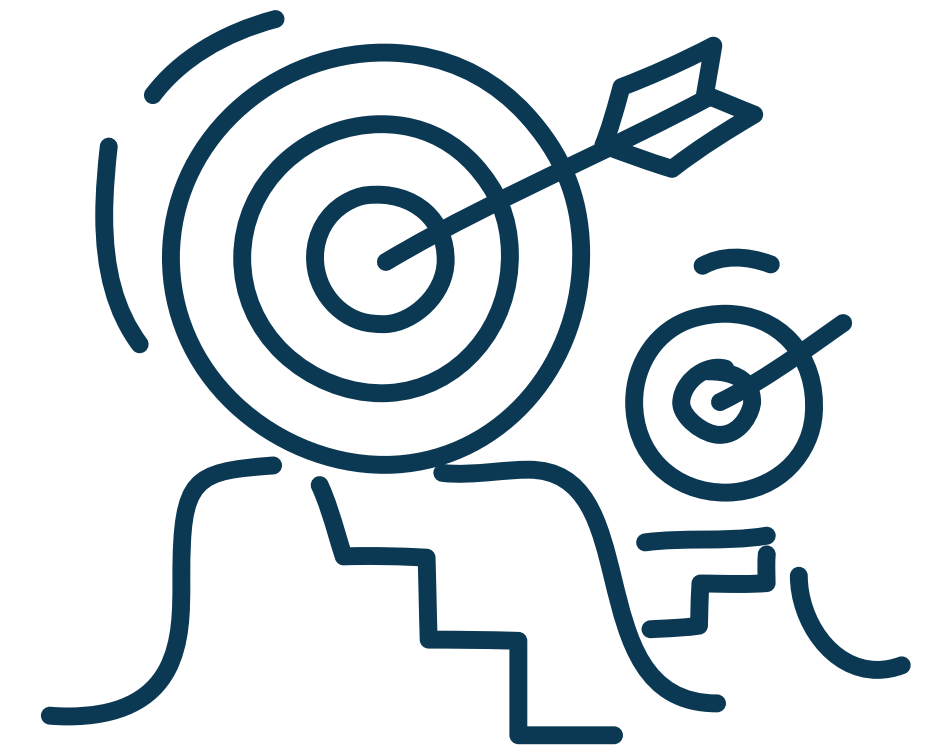
Ensuring that the amount of financial resources is sufficient new powers of local self-government bodies

Standardisation of powers by sectors

Further transfer of agricultural land from state property to the municipal property of AHs

Bringing the system of service at local self-government bodies in compliance with modern standards, differentiation of the positions of local self-government servants and elected officials of local self-government

Ensuring the advance training for local self-government servants



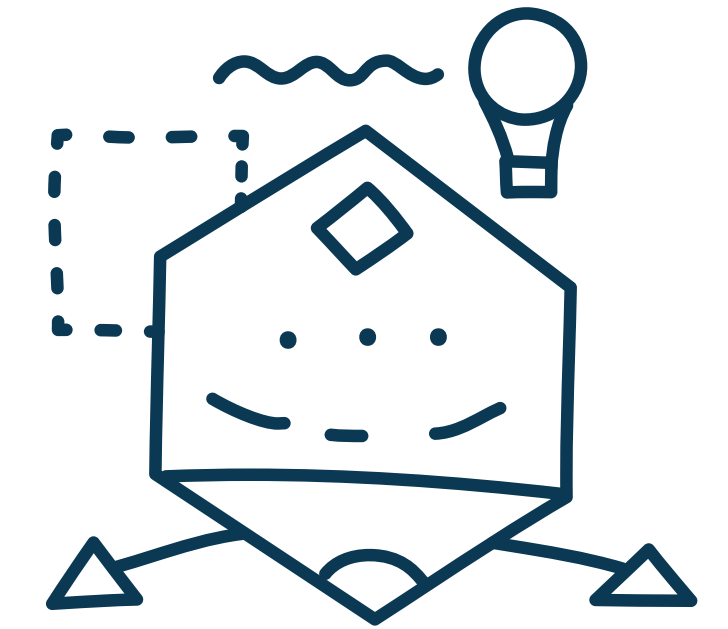
REGULATION OF THE SYSTEM OF STATE CONTROL AND SUPERVISION OVER THE COMPLIANCE OF THE ACTIVITY OF LOCAL SELF-GOVERNMENT BODIES WITH THE LAW



Introduction of unified state policy for the supervision and control over the compliance of the activity of local self-government bodies with the European Charter of Local Self-Government



6 DEVELOPMENT OF THE FORMS OF DIRECT DEMOCRACY: ELECTIONS, REFERENDA



Improvement of the electoral system for hromada councils, rayon and oblast councils regarding the proportionate representation of residents of respective settlements in AH hromadas and hromadas in rayon and oblast councils

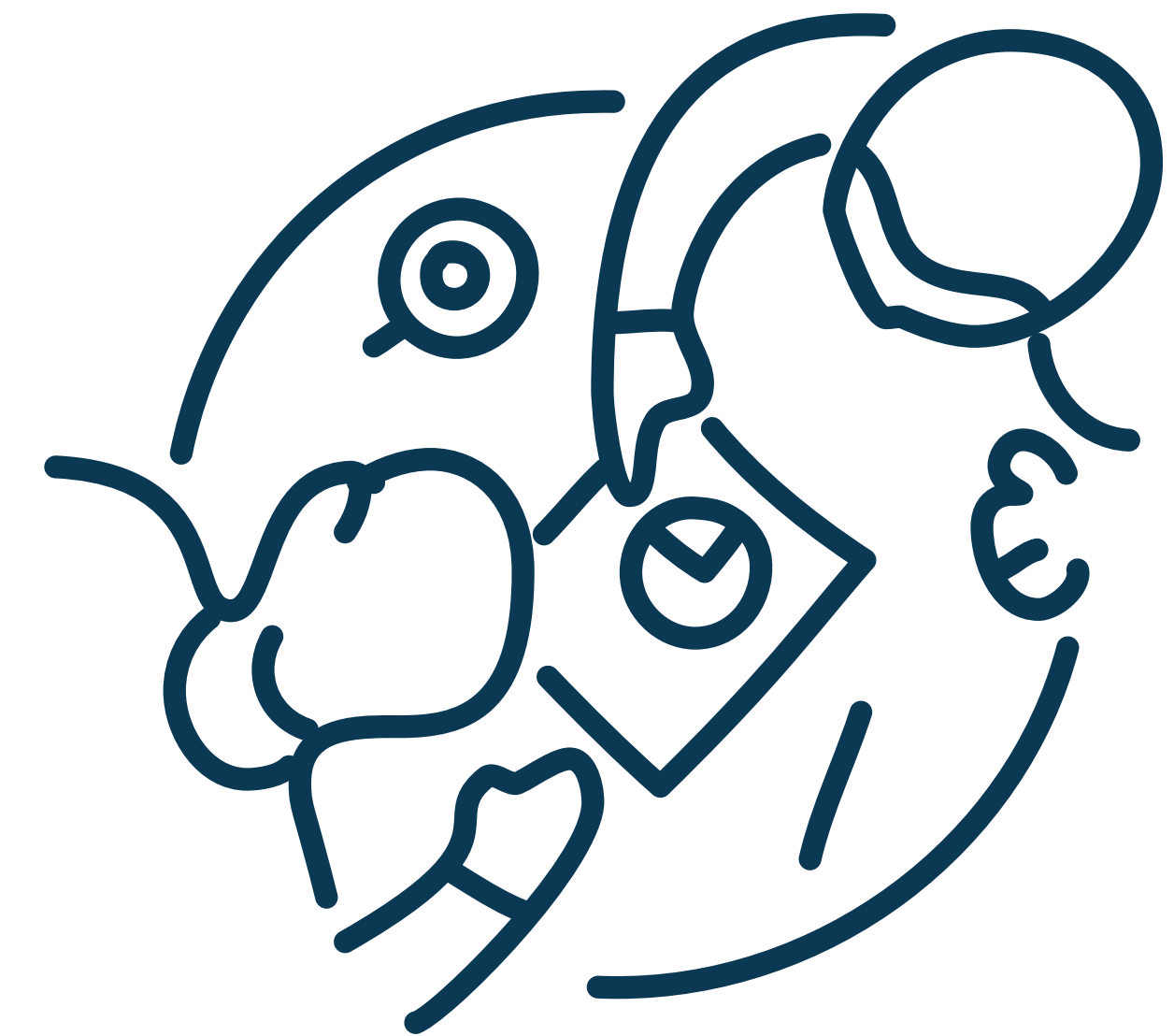
Regulation of the local referenda

Implementation of effective mechanisms of citizens' involvement in the preparation of draft resolutions of local self-government bodies



7 IMPROVEMENT OF THE COORDINATION MECHANISM FOR THE ACTIVITY OF CENTRAL AND LOCAL EXECUTIVE POWER BODIES

Enhance the proper coordination of the activities of central executive power bodies, oblast state administrations, rayon state administrations, territorial offices of central executive power bodies in a corresponding territory

Next elections scheduled for 2020 shall be held according to the new territorial structure of hromadas and rayons.
